Observations/Notes:

Noise caused by ongoing construction in the perimeter of the school was monitored using a sound level meter. Readings were taken in the basement hallway (20 feet from construction) next to the work performed today.

An average noise levels 46.07 db was measured for the day.

Dust levels within the perimeter of the school were measured. These readings can be found in the chart on the next page. Daily PM2.5 Density = 3.1, PM10 Density = 6.7

Work today included: Cutting rebar with 2-cycle saw, cement mixer running (mortar), deliveries of 3" river rock (dump truck), adjusting steel columns, cutting steel studs, installing and cutting of red brick, Cold Formed Framing above new MPR room, roofers installing copper flashing, Steer All running + excavator, Insulation hose being installed in the attic.

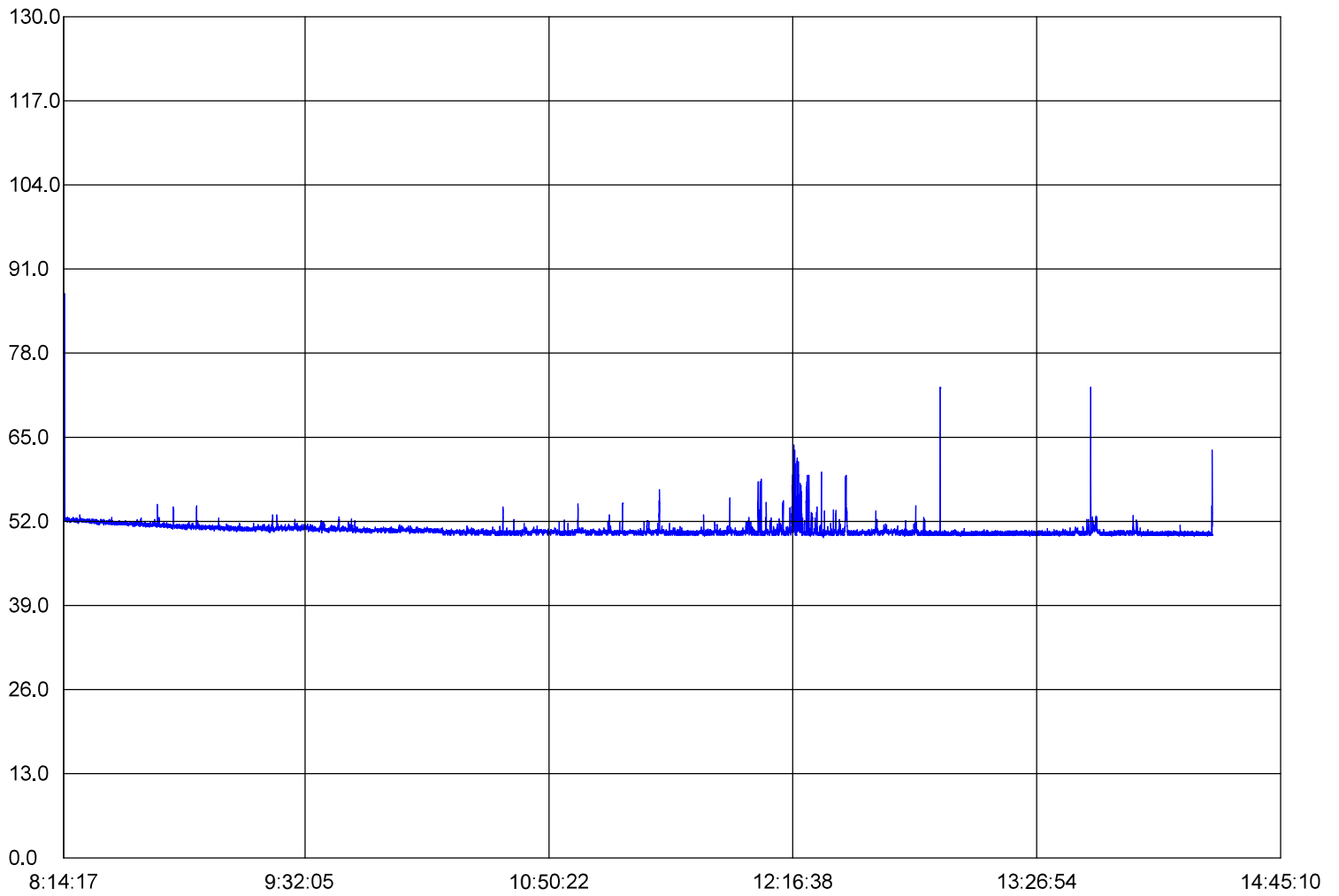

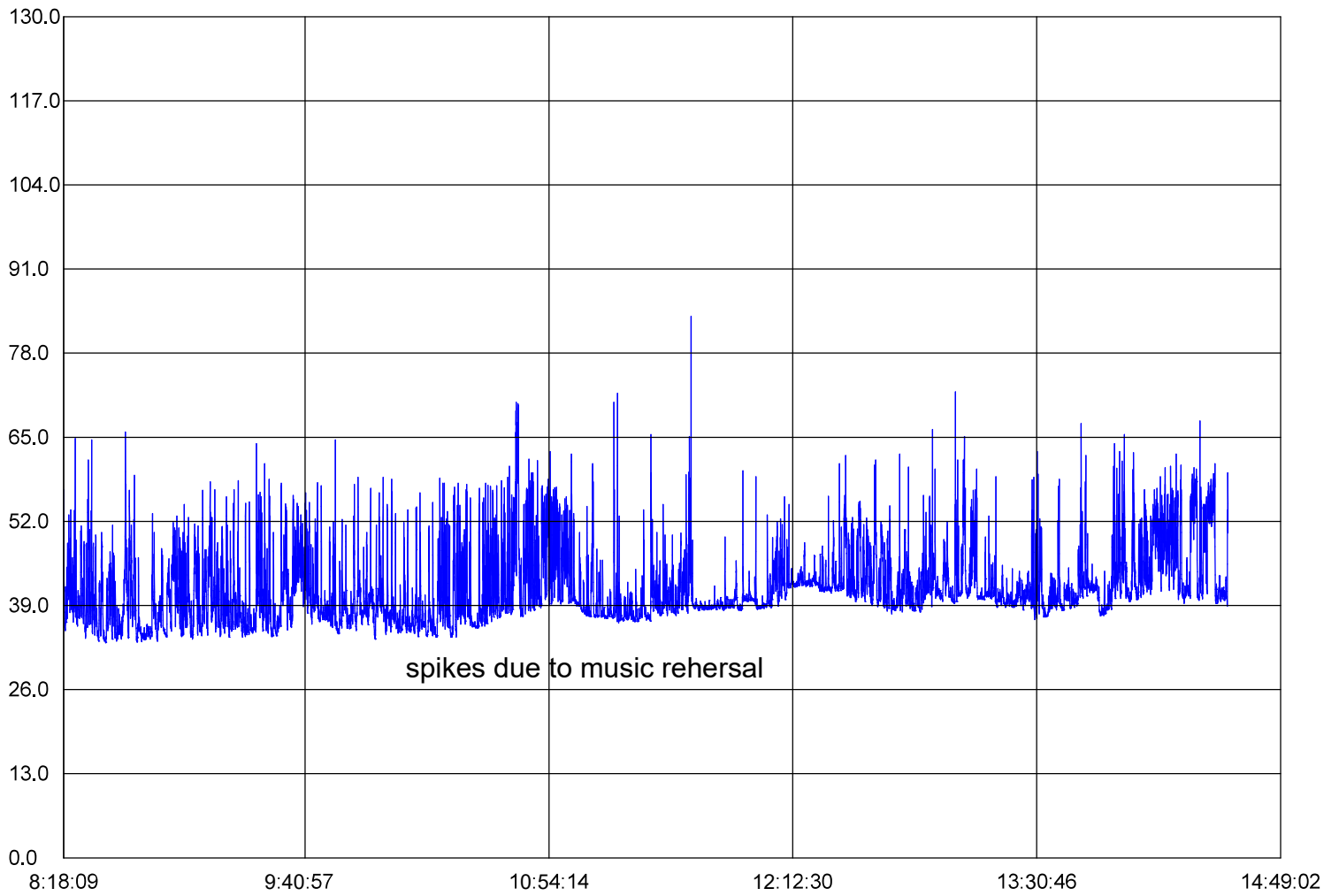
Standard Sound Level Meter RealTime Graph
