An Average noise level of 54.69 dB was measured for the day

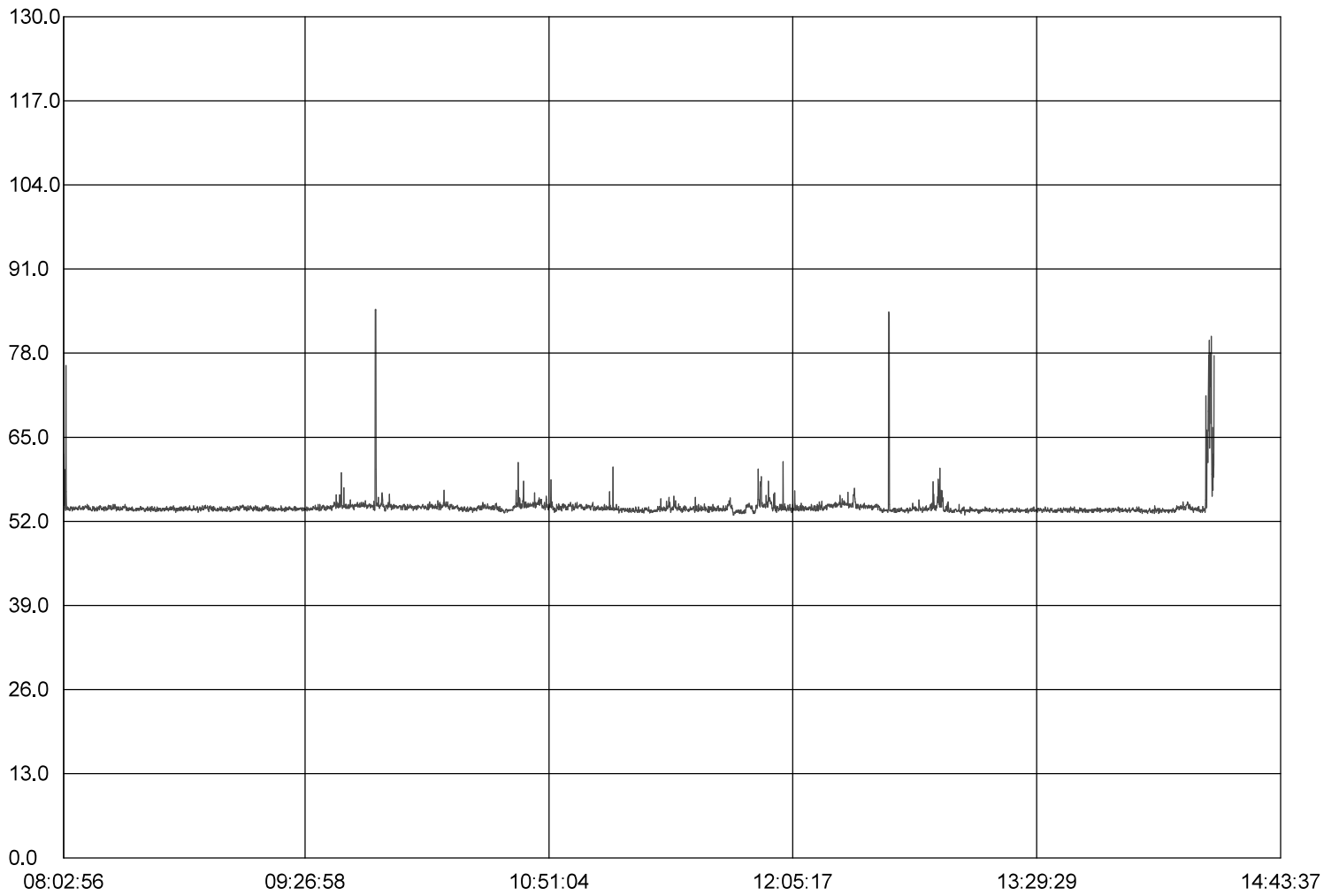

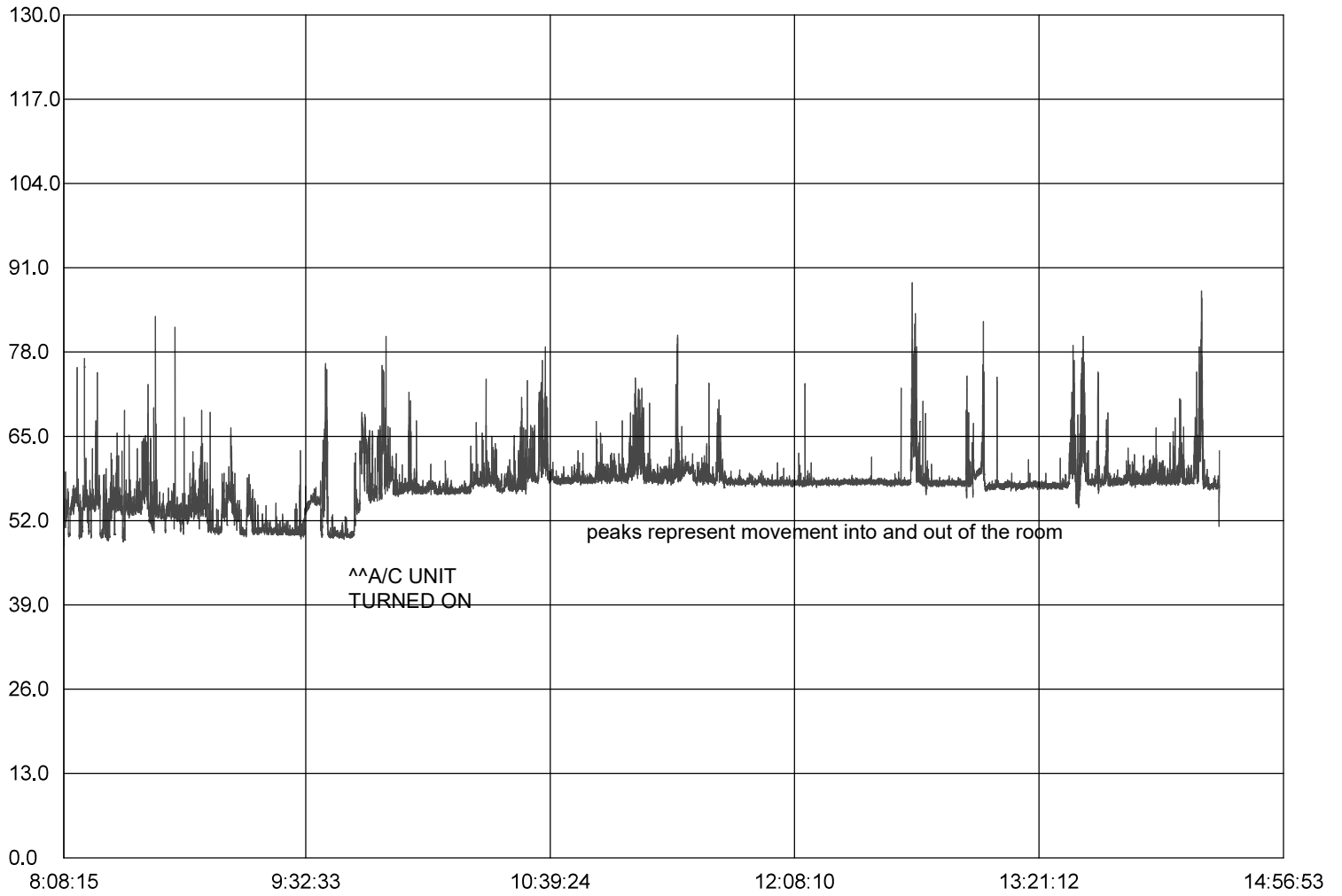
Standard Sound Level Meter RealTime Graph
