Noise caused by ongoing construction in the perimeter of the school was monitored using a sound level meter. Readings were taken in the basement hallway (20 feet from construction) next to the work performed today.
An average noise level of 53.368 db was measured for the day.
Dust levels within the perimeter of the school were measured. These readings can be found in the chart on the chart on the next page. Daily PM2.5 Density = 6.7, Daily PM10 Density= 12.8
Cutting concrete planks, 2 lull forklifts running, cement/mortar/grout mixer, CMU saw.

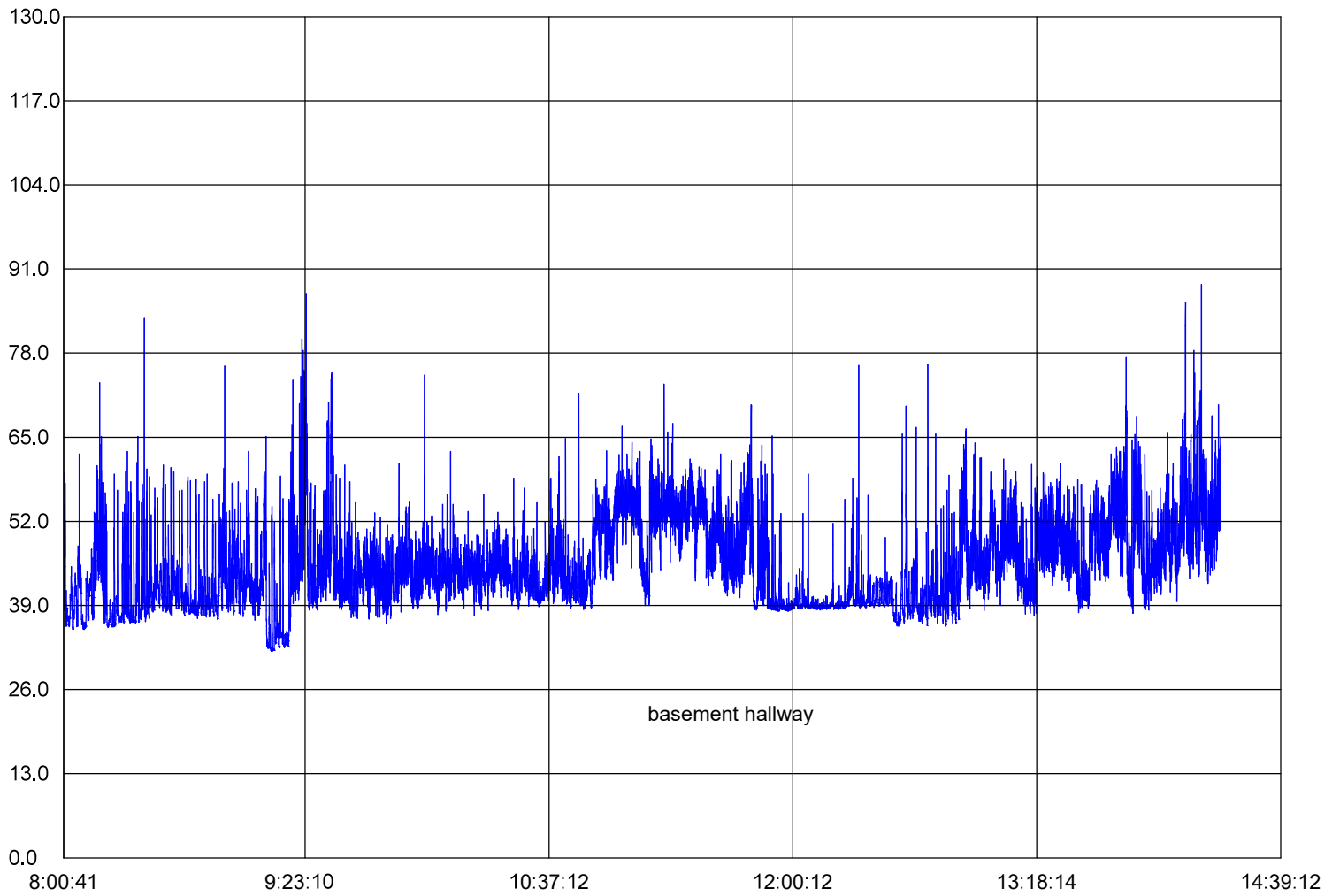
